Summer is coming to a close but unfortunately COVID-19 restrictions are increasing due to the highly contagious Delta variant. The Centers for Disease Control and Prevention (CDC) is in the process of determining when a booster shot will be recommended for those of us who have been vaccinated and encouraging those who have not been vaccinated to get the vaccine. Since then the Senate has passed their version of the spending package and now it is up to the House to pass theirs. They then get together and negotiate differences. I went to a Congressman Kilmer fundraiser in Tacoma earlier this month. At that meeting was Tim Thompson, the overseer to the local "Gorst Bottleneck" advocacy group. LEGISLATIVE UPDATE

Steve Ferguson here,

I sent the following email to Congressman Kilmer and both of our senators on 11 June 2021:

"When is the U.S. Senate going to address the cash shortfall projected by the Congressional Budget Office (CBO) for the Social Security and Medicare programs?

"Mr. Brian Riedl gave testimony to the Committee on Homeland Security and Governmental Affairs, United States Senate, on January 28, 2020. Mr. Riedl is a Senior Fellow in Budget, Tax, & Economic Policy of The Manhattan Institute for Policy Research.

"Mr. Riedl reported that CBO projects Social Security and Medicare programs will run a combined \$103 TRILLION cash shortfall over the next 30 years.

"Program adjustments are immediately required to steer away from this looming avalanche of debt." Derek Kilmer and Maria Cantwell had similar responses, saying they will continue to support Social Security and Medicare, programs that recipients have paid for throughout their working careers.

The unfunded liabilities of Social Security and Medicare are truly staggering. Those liabilities lie in the shadow of our current \$28.6 trillion national debt. The infrastructure bill recently adopted by congress will add \$256 billion to the national debt over the next ten years per the CBO. The Build Back Better reconciliation bill of \$3.5 trillion will add another \$2 trillion of debt and adds dental, vision and hearing benefits to an already underwater Medicare program.

According to a TheFederalist.com article by John Lott dated August 19, 2021, "Last September, the Congressional Budget Office (CBO) predicted the federal debt wouldn't hit \$29 trillion until 2028. Just short of a year later, the national debt stands at \$28.6 trillion and is set to surpass \$29 trillion within weeks."

Excessive federal debt fuels inflation and erodes the purchasing power of our life's savings.

Editor's Note: As of July 2021, the trend toward a 2022 COLA is 5.7 percent. The Consumer Price Index for August 2021 is scheduled to be released on 14 September. The official 2022 COLA will be released by the Social Security Administration in mid-October and is calculated by figuring the percent change between average prices in the third quarter of the current year (ending on Sept. 30) with the third quarter of the previous year.
