Last month I reported that our Past Region IX Vice President, Rich Wilson, was hospitalized for COVID-19. He has since passed away. He is managing the memorial for our state. Derek Kilmer, our 6<sup>th</sup> Congressional District Representative, wrote a nice tribute for Rich.

Midterm elections are still over a year away but NARFE-PAC is actively supporting fed-friendly candidates early this year. NARFE-PAC is helping them with a head start to accumulate a large incumbent war chest to ward off would-be challengers. So if you haven't contributed during this cycle yet, please do.

We will NOT have a Holiday Luncheon this year due to restrictions in place at The Willows. Instead we will hold a regular meeting at 1:00PM at the Westside Improvement Club. We WILL have our November Health Care Fair the morning of our November chapter meeting; the fair will open at 10:00AM with the 1:00PM program being the FEHB plan reps discussing their plans.

As for the \$1,000,000,000,000 (1 trillion dollars) infrastructure spending package that passed the senate last month, it is <u>still</u> being held up in the House of Representatives. Part of this money would assist our state to alleviate the Gorst bottleneck.

As for the inflation indicator, the CPI-W is at 5.9 percent inflation through August with one month to go to determine CSRS, Social Security, and FERS retirement income increases. The Equal COLA Act for FERS retirees is still held

Our state's proposed redistricting of local legislative district boundaries is being developed with public input being solicited starting 5 October 2021. Commissioners have received public feedback to reduce the number of legislative districts for cities and areas of shared community interests. Bremerton is one of these, presently with three legislative districts.

#### LEGISLATIVE UPDATE

Steve Ferguson here,

I did some quick math and see that July and August CPI-W values average 5.79 percent higher than last year's July, August and September average. The September CPI-W value, to be released on Wednesday, 13 October, will probably pull the average up to 5.9 percent for our Cost of Living Adjustment (COLA) making for a noticeable monthly annuity increase. What isn't noticeable is the loss in value of savings you maintain in the bank.

I sent this email to Congressman Kilmer on 30 August:

"The Congressional Budget Office, in testimony to the U.S. Senate, January of 2020, projects that Medicare will experience a \$44 trillion cash shortfall over the next 30 years.

- 1) How will the projected cash shortfall be remedied?
- 2) Is advocating the addition of vision, dental and hearing coverage to Medicare prudent considering Medicare is vastly underfunded already?"

I have not received an answer from his office. I consider no answer to be an answer. Congress continues (this has been the case for decades) to not have the political will to address massive Medicare and Social Security funding shortfalls. It is like a slow-moving train approaching a collapsed bridge. The engineer(s) will not apply the brakes and the passengers aren't saying a word.

It is impossible to create a funding solution that will yield popular public support. Any solution will provide some level of pain. The most painful solution of all will be to continue to do nothing until the train crashes to the bottom of the ravine.

Years ago, I was seeing large private companies fail and pensioners losing their pensions. (Actually, the Pension Benefit Guarantee Corporation stepped in and now provides at least a part of that person's pension). I have to laugh at myself now because I was thinking, at the time, how lucky I was because my retirement was as solid as the U.S. Government. Yep, now I am rethinking what I was thinking.

**Be wary of phishing emails and texts!** If an email account is compromised, scammers may try to send fake emails to names on that email contacts list. Posing as that person, they will try to obtain personal

information from those contacts. The emails LOOK like they come from someone you know; vague wording asks for assistance or says they'll be back in touch shortly. You should immediately delete these. If you're not sure, contact the person by phone or a new email thread to see if they really sent that email. If they didn't, it means their email account has been compromised.

If you text, there have been phishing texts that are addressed to the "wrong person" stating they've won something and providing a link to claim the prize. Delete the text and select the option to block the number from which it came.
