Executive Board meetings are held from noon to 2:00PM at the Westside Improvement Club the Wednesday prior to general meetings. Members are welcome to join us.

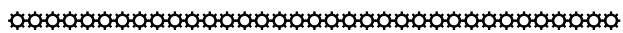

LEGISLATIVE UPDATE

Steve Ferguson here,

Federal Employee Health Benefits (FEHB) **Open Season** is upon us. You are eligible to change coverage from **Monday, 8 November through Monday, 13 December**. About 5 percent of federal employees change plans during open season. I will stay with my Kaiser Medicare Advantage Plan that reimburses \$100 per month directly to my checking account. That makes my Medicare Part B premium effectively \$48.50 per month.

What will Medicare Part B premiums look like for 2022? I am seeing a probable \$5 per month increase from \$148.50 per month to \$153.50 per month for most people. Your rate is based on reported income from two years prior. Medicare uses the "Income Related Monthly Adjusted Amount" (IRMAA) table. Filing jointly, the current annual income brackets are: Up to \$176,000 = \$148.50 premiums; over \$176,000 to \$222,000 = \$207.90 premiums; over \$222,000 to \$276,000 = \$297 premiums; and so forth to a maximum Part B premium of \$504.90.

The financial problem with Medicare is that the average person derives three times as much in benefits as what they paid in.

The national debt continues to soar and is expressed in terms of trillions of dollars. One trillion is a difficult concept to grasp. I recently encountered the following explanation of how to understand the relationship between one million, one billion and one trillion:

One million seconds = 11.57 days
One billion seconds = 31.71 years
One trillion seconds = 31,710 years

We all need to pay attention when we hear about NEW government spending of \$3.5 trillion. We can't pay for current obligations without borrowing money.
