This past year we have managed to get through the COVID-19 restrictions and started meetings again. Hopefully the new South African strain of this virus, omicron, won't affect the us.

With the November election, our slate of officers is good for another two years. I want to thank our officers for donating their time and give a "thank you" to those attending our chapter meetings since we returned to in-person meetings. I also want to thank Congressman Kilmer for his support and attendance at Zoom meetings.

We won't have a holiday luncheon this year due to COVID-19 restrictions but will have Mayor Wheeler report about the city of Bremerton. The city has had several good changes in the past year that he will be happy to talk about. Also, Steve Roy, president of our Washington State Federation, will install our 2022/2023 slate of officers.

With the federal government's infrastructure package signed into law, we will schedule a speaker to report on the Gorst corridor resolution when plans to alleviate the traffic have begun to coalesce. We will probably invite Tim Thompson of the Gorst Coalition. (Editor's Note: I would like to assemble a panel of speakers consisting of a representative from the Gorst Coalition, Mayor Wheeler, Congressman Kilmer or his representative, and state senator, Emily Randall, or her representative.)

As reported last month, hopefully congress can exert some serious effort toward postal reform after resolving Biden's social spending package. NARFE is favorable toward the USPS Fairness Act which will eliminate some of the biggest challenges USPS faces and shore up its finances.

NARFE now gives retirees who donate monthly (sustainers) to NARFE-PAC the option to switch to annuity withholding. OPM operates the annuity withholding process. After completing a form for NARFE, members can sign up for and manage their contributions through their OPM Retirement Services Online account. OPM will then withhold your monthly contribution on the first of each month and send it to NARFE-PAC; the contribution will be noted on each annuity statement.

### LEGISLATIVE UPDATE

Steve Ferguson here,

This is newsletter article #66 from me, and my final article as I'm stepping down as your legislative chair.

So much for me saying Medicare premiums would increase about \$5 per month in last month's newsletter; I missed that by a factor of four. The premium will increase to \$170.10 per month.

I am looking forward to a response from Congressman Kilmer's office on this letter:

"In regard to H.R. 5376 (Build Back Better), the Congressional Budget Office scores it as adding \$376 billion to the national debt over the next 10 years.

"H.R. 5376 expands social program expenses. The U.S. Government's Consolidated Financial Statements of September 30, 2020 report the government owns \$102 trillion in liabilities and unfunded promises. Social Security and Medicare account for \$65 trillion of that amount.

"Why did you vote to expand social spending when the U.S. Government does not appear to have a plan to pay for existing obligations? Thank you."

I am concerned because my retirement check is paid by the same government that owns the vast liabilities described above. Are you concerned?

H.R. 5376 spends over \$200 billion on green energy. Germany made a superb attempt at converting to green energy to reduce their carbon footprint at the cost of hundreds of billions of Euros. They did not reduce their carbon footprint but they did increase consumer energy costs by 50 percent from 2006-2017. Green energy costs to the consumer are forecast to increase indefinitely.

France, on the other hand, has consumer energy costs 41 percent less than their German neighbor. France is 72 percent nuclear powered. Germany has been leaning hard on France to increase wind and solar. Consequently, energy costs in France are on the rise.

What is our nation going to do differently that will yield a green success story? Or do we need to budget for immensely more expensive electricity as inflation soars?

Our region is forecast to experience electrical supply shortages in the near term. I am investing in an energy efficient wood stove now. It will be a lot of work but at least I'll have a source of heat if the lights go out.
