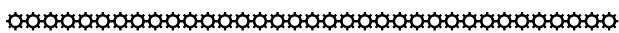

Step one: Call OPM at 1-888-767-6738 to set up annuity withholding for NARFE-PAC contributions.

Step two: Call the NARFE advocacy department at 1-800-456-8410, option 3. Tell them you've registered with OPM for annuity withholding and they will end your credit card payment.

## LEGISLATIVE UPDATE

We still have one more year left in the 117th Congress. As such, NARFE Grassroots Advocacy is key to our legislative successes. I encourage you to stay turned by signing up for NARFE's weekly *Newsline* email and frequently visiting NARFE's Legislative Action Center at the following link:

There are currently two pieces of Windfall Elimination Provision (WEP) legislation that we need our congressional representatives to co-sponsor:

### **H.R. 5834 – Support the Equal Treatment of Public Servants Act of 2021**

Introduced in the House by Rep. Kevin Brady, R-TX, this is the latest bill that would provide financial relief to more than 1.9 million Social Security beneficiaries affected by the WEP.

For individuals who are first eligible for Social Security benefits before 2023 (turning age 62 before 2023): Under the bill, individuals receiving WEP-reduced Social Security benefits based on their own work record would receive a payment of \$100 per month. Meanwhile, spousal and child beneficiaries receiving a WEP-reduced Social Security benefit would receive a payment of \$50 each month.

For individuals who are first eligible for benefits between 2023 and 2060 (turning age 62 in 2023 through 2061): These individuals' WEP penalty would be subject to either a new formula created by the bill or the current formula, whichever is more beneficial. The new formula would calculate benefits based on the proportion of a worker's career earnings in Social Security-covered jobs to total earnings in covered and non-covered jobs.

For individuals who are eligible for benefits starting in 2062 (age 21 and under in 2021): These individuals' WEP penalty would be calculated with the new formula only.

### **H.R. 4788 – Support the Wellbeing for Every Public Servant Act**

This legislation would fully repeal the WEP for retirees with a combined non-Social Security covered annuity and Social Security benefits of \$5,500 and lower. For those with benefits above \$5,500, the WEP repeal gradually phases out, and for combined incomes at \$6,333 and above the WEP penalty is fully applied.

To date, no congressional representatives from Washington State have co-sponsored these pieces of legislation. I urge you to contact them by either using the NARFE Legislative Action Center on the National website to write a letter; or by calling the NARFE Legislative Hot Line at 800-456-8410 option 5. Follow the prompts to reach your congressional representative.
