#### **PRESIDENT**

Our congressman, Derek Kilmer, had an online Town Hall meeting in April that I attended in listen-only mode. He had a very good turnout with call-in and computer online message questioning. He included questions from various areas in our congressional district including Bremerton and Port Orchard.

He went over the \$1.9 trillion 2021 America Rescue Plan, also known as the COVID-19 stimulus package, which gave relief to families and boosted the economy; and the \$1.2 trillion infrastructure bill that is to be spent over the next eight years. He covered specific items for our congressional district in this bill, such as portable housing for homeless in Tacoma, flood protection in the Grays Harbor area, downtown Bremerton Quincy Square development, planning for the Gorst bottleneck, and jobs in the hilltop area of Tacoma.

Congressman Kilmer commented on the funding formula for highways and bridges from the infrastructure bill for our state and said that, architecturally, our state got a C- engineering grade. He mentioned how rural areas in our district do not have high speed internet and that part of the infrastructure package goes toward broadband.

He briefly discussed Title 42 immigration policy. This expulsion policy is used to block border crossing by asylum seekers citing COVID-19 concerns. He says they need to reduce processing backlog and address root causes in Central America. He addressed the H-1B visa program for high tech workers. The Biden administration allowed the H-1B suspension of high-tech workers to expire.

He briefly covered the supplemental \$13.6 billion spending bill for defense assistance to Ukraine, including training and use of equipment.

He also covered student loan debt. He does not think they should be forgiven but thinks that federal Pell grants for financial aid should be doubled and tied to inflation. He also thinks that student loans should be refinanced.

Congressman Kilmer was sympathetic about gasoline prices but only commented about the federal petroleum reserve usage and oil company price gouging.

#### THE POSTAL REFORM ACT

In our February newsletter we published an article, "Our Troubled United States Postal Service (USPS)", that outlined postal reform proposals facing legislators. Our April newsletter announced the final passage into law of the Postal Reform Act. This month we are reviewing this historical legislation that puts the postal service on a path toward financial stability and stops further atrophy in service to millions of customers.

This reform has been 15 years in the making since the prefunding mandate was established in 2006. The mandate required the postal service to prefund 100 percent of retirees' health benefit liabilities. This automatically put the postal service finances into the red at a cost of \$5.5 billion a year. The Postal Reform Act eliminated the mandate and restored the pay-as-you-go system.

The Act also covered three other items, the first being the need to ensure sixday delivery, and that letter mail will remain combined with package delivery into one postal network. This will help capture projected package growth in the future.

Second, the legislation brings much needed transparency to postal operations. For this the postal service will set up a dashboard on their website. The public and postal union can then monitor service failures and pinpoint ZIP codes experiencing diminished performance. One item of common complaint is flats (large envelopes).

Third, is maximizing participation in Medicare. Medicare integration is required because it is the only way to capture savings. There will be a special postal group established for retired postal employees over age 65 in the Federal Employees Health Benefit (FEHB) program. Retirees will be required to sign up for Medicare Part B and make their FEHB plan a secondary insurance. Roughly 80 percent of previous retirees have already joined Medicare Part B.

This legislation protects and strengthens the people's public postal services with bipartisan passage. It is a victory for postal workers and the communities they serve.

#### **MEMBERSHIP & MUSINGS**

In February the Postal Reform Act was signed into law. This legislation was good for postal and federal workers alike.

There is a proposal, H.R. 6398, in Congress that would provide federal employees a 4.1 percent pay raise plus a 1 percent increase in locality pay. Pay raises are not a Cost of Living (COLA) adjustment for employees. COLAs are intended to help retirees' annuities keep pace with inflation. You may want to read more about this in the April *NARFE Magazine*.

The Centers for Medicare & Medicaid Services are standing by their decision to restrict coverage for Aduhelm to people enrolled in a clinical trial. There is

nothing yet on the request by Congress to revisit the large increase in Medicare premiums.

A new Alzheimer's patch, Adlarity, won approval from the Food and Drug Administration. Administered once a week, it delivers doses of donepezil, the most prescribed Alzheimer's medication for treating mild, moderate or severe Alzheimer's dementia.
