Election of National and Regional Officers and Vote on Bylaws Amendments

This year an election for National President, Secretary Treasurer and the 10 Regions vice-president offices will be held. Amendments to the National Bylaws will also be voted upon. Treasurer's Report

Our month end May balance is \$14,994.40. Dues collected in May were \$89.06. A check for \$291.76 was received due to the closure of East Lake Washington Chapter 1404.

OPM Retirement Accounts - Important

Do you have online access to your OPM retirement account at servicesonline.opm.gov? Now you will see a new process for signing into Services Online. To log in you will be prompted to create a new username and password with login.gov. After that, whenever you log into the Services Online site, you will use the login.gov username and password, as well as a special code which they will text or email to you to authenticate your identity and protect your account. You will no longer log in using your retirement claim number and password.

TSP Accounts

Effective 1 June you must create a new user ID, password, PIN number and select 2 security questions to log on to your TSP account. The TSP site will take you through the process on a step-by-step procedure. Once you are in your account you will find a new format.

COLA UPDATE

The CPI-W increased 0.494 percent in April 2022. This is a 6.018 percent increase from the Jul/Aug/Sept 2021 average of 268.42066. If inflation continues at this pace, the COLA for 2023 annuity adjustment may again be in the 5 to 6 percent range.

FEDcon 22 Scholarships

The Fedcon22 will be held August 21-23 at the Westlin Kierland Resort & Spa in Scottsdale, Arizona. All the details and registration are at fedcon.narfe.org. Of particular interest to seniors, there will be a presentation on how to declutter your life, downsize and move forward with your life. Legislative Action

On May 3, Reps. Eleanor Holmes Norton, D-DC, and Dutch Ruppersberger, D-MD, introduced H.R. 7657, the Reducing the Effects of the Cyberattack on OPM Victims Emergency Response Act. Dubbed the RECOVER Act, this bill would provide a lifetime's worth of free identity protection coverage for those whose data was breached during the 2015 hack of the Office of Personnel Management. A previous version of this bill was approved by Congress in fiscal year 2017 appropriations. However, the bill failed to provide afflicted employees with identity protection beyond fiscal year 2026. Norton stated that "because there is no limit to the duration on when the compromised personal information can be used, Congress must protect these federal employees and contractors in perpetuity." Ruppersberger shared a similar sentiment, stating that affected federal workers' personal information has "no shelf life," so neither should identity protection related to the data breaches.

With NARFE's support, Sen. Alex Padilla, D-CA, introduced <u>S.4221</u>, the Equal COLA Act, on May 16. Companion legislation to <u>H.R. 304</u>, S. 4221 would ensure that cost-of-living adjustments (COLAs) to Federal Employees Retiree System (FERS) annuities match the measured change in consumer prices. Mirroring its House counterpart, S. 4221 would provide full COLAs to FERS retirees, creating parity with Civil Service Retirement System (CSRS) and Social Security COLAs. Without this amendment to the current system, FERS retirees will continue to see their annuities, earned through years of dedicated public service, decrease in value annually – the very issue COLAs were designed to prevent
