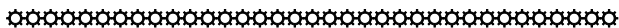

GOP/WEP

In June's newsletter I wrote an article concerning GPO/WEP. In that article I explained why the government initiated these unpopular laws. Refer to our district website which lists all prior newsletters if you want to refresh your memory about this article.

The September issue of our *NARFE Magazine* has an article titled "NARFE Continues Push to Repeal WEP and GPO". This is House Resolution 82 and Senate Bill 1302 in our magazine's *Bill Tracker*. The House should have enough co-sponsors before the close of the 117th Congress to force a vote. However, the Senate is the problem. There isn't enough support in the Senate to get this passed. According to GovTracks.us, this legislation only has a 2 percent chance of passing.

As I said previously, the only way this legislation will get passed is compromise. It will be too expensive to pass the legislation as presently written and it would violate the dual entitlement rule.

COLA UPDATE

The June CPI-W value was 292.542. The Jul/Aug/Sep 2021 average was 268.42066 so inflation was up 8.98 percent from that reference point. Inflation increased 1.569 percent in the month of June. That is an annual inflation rate of 18.828 percent.

On 10 August, the Bureau of Labor and Statistics reported deflation in the month of July of negative .11 percent (one tenth of one percent). I am guessing gas prices coming down helped.
