PRESIDENT

Our secretary hosted a successful panel discussion concerning the Gorst bypass for our September meeting. We advertised the meeting in the Kitsap Sun newspaper, our newsletter, on FEDHub, Facebook, Nextdoor and on the district website. The panelists for the discussion were Captain Richard Massie of Naval Base Kitsap, Congressman Derek Kilmer, State Senator Emily Randall, Bremerton Mayor Greg Wheeler, Port Commissioner Axel Strakeljahn, and Suquamish Tribal Representative Alison O'Sullivan. Josh Farley, Kitsap Sun reporter, covered the meeting and wrote a front-page story in the Wednesday, September 14, 2022 newspaper. Ironically, a Waste Management garbage truck, traveling through Gorst that afternoon, had a front tire blow out causing the truck to overturn, closing

Highway 3 for 90 minutes. Several chapter members, as well as some panelists, spent hours trying to reach their destinations after the meeting.

The state presently has \$75 million to determine the route, either over or around Sinclair Inlet, and to design the project. Funding to construct the revised corridor will be at least \$500 million, but probably more.

Bill Shackelford was elected as the new NARFE National President; his two-year term begins in January 2023. His emphasis will be on lobbying. He also wants to redraw chapter boundaries to coincide with congressional districts. The chapter president would evolve into a Congressional District Leader (CDL). This means that the Sequim/Olympic Peninsula Chapter 1006 would be incorporated into our chapter. It also means that the Seattle Chapter 0043, which is already weak, would be split up to coincide with the congressional districts along the I-5 corridor. We will provide additional information regarding the status of these proposed changes once Bill Shackelford takes office.

Cray Henry, a National-only member from Port Hadlock (north of the Hood Canal Bridge), has been nominated for **Washington State Federation (WSF) President**.

President cont. He has an information technology background in the Department of Defense including legislation relations and conference management. He was recruited to fill the position because our current WSF President, Steven Roy, has been elected as the NARFE Region IX Vice President covering Washington, Oregon, Idaho, Montana and Alaska. Steven is replacing the current Region IX VP, Linda Silverio, who is moving out of our region.

Mary Traxler, a member of the Olympia/South Puget Sound chapter, has been nominated for **WSF Vice President**, replacing Mary Binder, who is stepping down due to health and family issues. Mary Traxler serves on the Olympia chapter advisory committee as their program coordinator.

Arlene Patton and **Linda Wallers** have agreed to continue serving as **WSF Treasurer** and **WSF Secretary** respectively.

Elections are now LIVE; if you didn't receive an email invitation to vote, please contact Bea Bull. You may tell her for whom you wish to vote: The four people (**in bold**) listed above or "write-in(s)". She will submit your vote to the federation. Elections close at noon PST on 10 October with newly elected officers beginning their term on 13 October after the federation virtual conference. Once the new officers have settled in, we will invite Cray Henry as a guest speaker at a future membership meeting.

We continue to watch the status of H.R. 82. This legislation, with 299 co-sponsors, was placed on the House Consensus Calendar, which put it in line for a potential House floor vote. However, the House Committee on Ways and Means scheduled a markup for the bill on 20 September. According to an email from NARFE President Ken Thomas, "this removes the bill from the House Consensus Calendar, altering the path for potential floor consideration. But it also represents the most significant official action taken to advance the bill ever, and could still set the stage for a full House vote. With committee action imminent, now is a pivotal time to keep up pressure on representatives and House leadership to bring it up for a vote."

If you received the email from NARFE President Ken Thomas on 19 September and tried to use the link to contact your congressional representative, you will have found that it didn't work. Yes, there was a computer glitch that day. It is now working

so I hope you take the time to fill out the form; it's not too late.
