Last month I stated that our incoming NARFE president was going to implement Congressional District Leaders (CDLs) when he took office in January. This would do away with more than one chapter in a congressional district. It was brought to his attention that this concept would create problems in certain USA areas such as along the 1-5 corridor, as I mentioned in last month's article. He has now backed away from this proposal. We will report future organizational proposals as they develop.

Last month I reported that we had a successful panel discussion concerning the Gorst corridor. This month I went to a meeting at the Wigwam Pub hosted by the Thompson Consulting Group. Tim Thompson is the chairman of the Gorst Coalition. This meeting was attended by Derek Kilmer, Emily Randall, Charlotte Garrido, and several Navy, port district and union representatives. The main

message out of this meeting was to join the Gorst Coalition and let our representatives and state highway commission know your concern to fix this problem. It has been on the back burner too long and gets worse monthly. So, join the coalition and speak out. Kitsap residents need to keep pressure on federal and state resources to address this safety and traffic problem. Funds have been appropriated for engineering and impact study but these are just the initial steps. The website to join the coalition and get updates is www.gorstcoalition.com.

We are resuming our holiday luncheon tradition this year. Our chapter and some members are providing additional funds to offset the luncheon cost. Inflation Reduction Act of 2022

This bill, which passed without a single Republican vote in either chamber, offers \$369 billion in incentives over the next ten years to accelerate expansion of clean energy. This will be addressed later in the article. It also invests \$64 billion in

extension of the Affordable Care Act (Obama Care) for three years, through 2025.

On the revenue raised side, it will establish several tax changes, the being the 15 percent corporate minimum tax on book Corporations income. will compute two separate calculations for federal income tax purposes and pay the greater of the new minimum tax or their regular tax liability. This is estimated to bring in \$313 billion over ten years. Prescription drug pricing reform empower Medicare negotiate drug prices for the first time and it would cap Part D outof-pocket costs at \$2,000 per year starting in 2026. This includes cost sharing for a month's supply

of insulin capped at \$35 for 2023 through 2025. It is estimated that prescription drug pricing reform will save the government \$288 billion over ten years.

Internal Revenue Service (IRS) tax enforcement provisions in this bill include expansion of the IRS budget by \$80 billion over ten years. There will be 87,000 new IRS agents. The Congressional Budget Office (CBO) estimates an additional dollar of enforcement spending will yield between \$5 and \$9 in additional revenue. This is estimated to save \$124 billion over ten years.

Carried interest loophole is finally being addressed. Fund managers who receive carried interest (who tend to be among the wealthiest people in the country) get a tax break on that income. The loophole treats the earnings as capital gains, so they're currently taxed at a top rate of 20 percent rather than the top tax rate of 37 percent. This correction to 37 percent is estimated to bring in an additional \$14 billion in revenue.

Back to the expansion of clean energy. Electric car buyers are eligible for a tax credit of up to \$7,500 as long as the vehicle runs on a battery built in North America with minerals mined or recycled on the continent. The problem is, this creates a trade

barrier against foreign producers. The new energy efficient home rebate program can give up to \$8,000 in rebates or up to \$14,000 for installing a heat pump and electrifying your home. These funds will be available through September 2031.

There are many more climate change actions being taken behind the scenes such as incentives to replace

> school and transit buses, service delivery postal vehicles, and garbage trucks with zero emission vehicles. However, an electric transit bus recently caught fire and the city pulled the electric bus fleet from operation following the fire. The manufacturer is investigating.
