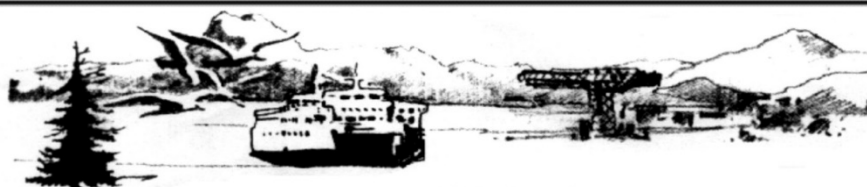

The elections are over and the 117<sup>th</sup> Congress 2<sup>nd</sup> session only has two and a half weeks left before the Christmas/New Year break. When the House of Representatives reconvenes for the 118<sup>th</sup> Congress, they will have new leadership. This present lame-duck session probably will not address any of our "Bill Tracker" items; instead, they will address pertinent items needed to keep our government functioning.

The Federal Reserve will continue to raise the federal funds rate, the basic interest rate banks use in order to slow inflation. This quickly affects the housing market which is interest rate sensitive and will affect housing for months to come. Their goal is to decrease inflation down to approximately 2 percent, which is what it was for years during our economic growth.

However, board members are concerned that price pressures are becoming embedded in goods and services. Expect a few lean years with gridlock in Washington, DC while things sort themselves out for our future direction.

I would like to thank those of you who signed up for our holiday luncheon at the Bremerton Elks Lodge.

I am also reiterating the need for a currently employed federal employee to join our executive board as a spokesperson for our younger chapter members. I'm sure there are many things we should be doing to attract and retain our younger members. The "A" in NARFE is active which means not retired.

## **GPO/WEP**

We previously wrote about Government Pension Offset (GPO) and Windfall Elimination Provision (WEP) in the June, September, and October newsletters. NARFE has an article on this subject in both the November and December magazines. GPO affects people who earned a government pension and are married to someone covered by Social Security. They can apply for Social Security spousal or survivor benefits based on their mate's account, but their monthly benefit will be reduced by two-thirds of the amount of their public pension. If their public pension is large enough, their Social Security benefit goes to zero. WEP affects people who received both social security and a government or public service pension. Social Security pays a smaller percentage of their covered earnings than it pays people who worked mostly in the private sector. Both implement the dual entitlement rule.

NARFE finally obtained the required 290 cosponsors (now 305 cosponsors) to force a vote in the House of Representatives on the Social Security Fairness Act, HR 82. There was an attempt to prevent a floor vote of this act with a rule change. In response, legislative leaders and NARFE National President Thomas raised alarm bells with members of Congress and reversed the late rule change. However, the cognizant and powerful Ways and Means Committee held a business meeting where it reported the bill. In doing so, it avoided a floor vote! The reason this slick maneuver was initiated by congressional leaders is they feared insolvency of Social Security due to the cost of implementing HR 82. Like I said in our June newsletter, this is a hot-button topic. This plus the current push to reform Social Security to keep it solvent will, hopefully, lead to compromise in the next 118<sup>th</sup> Congress.

## **COLA UPDATE**

The October CPI-W value is 293.003. That means we pay \$2.93 to buy what we paid \$1.00 for in 1983. The inflation increase over September is .3936 percent, or just under 4/10 of a percent. The index Jul/Aug/Sep average is 291.90066, which is the baseline number for computing the 2024 COLA. October inflation stands at .3776 percent over the Jul/Aug/Sep average. That is not too bad.

## MEMBERSHIP & MUSINGS

I was asked a few weeks ago to make a few comments about legislation before Congress and its recent difficulties. The subject was the Social Security Fairness Act, HR 82, a bill to repeal both the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). Now for a little history. I attended my first chapter meeting in February 1993 and this was old news then; NARFE had already been trying to repeal this law for several years by that time.

By July of this year, HR 82 received enough (290) cosponsors to be placed on the House Consensus Calendar, for a possible vote. This is the first time we have ever moved a bill on this topic this far and it happened because members like you stayed in contact with your legislators. Unfortunately, according to an article on the NARFE website, “with that vote imminent, the House Committee on Ways and Means held a committee business meeting where it reported the bill. In doing so, it removed the bill from the House Consensus Calendar, avoiding a floor vote.”

The article continues, “While it was clear the purpose of the hearing was to prevent a floor vote on full repeal – due to concerns about Social Security solvency, primarily, according to committee leaders – every committee member who spoke at the hearing expressed a desire to address the inequities of WEP and GPO. Committee leaders support a more limited approach to reform WEP/GPO, as opposed to full repeal, but they did commit to working towards an agreement on mitigating the effect of the penalties.
