#### **PRESIDENT**

Our NARFE National Senior Vice President of Policy and Procedures, John Hatton, put on a webinar last month that covered the five key items I listed in our February newsletter:

- 1. Protect retirement and health benefits
- 2. Undertake OPM modernization
- 3. Federal pay increases for 2024
- 4. Support/reform GPO/WEP
- 5. Full COLAS for FERS retirees

I reiterate these items because in President Biden's "State of the Union" message to Congress, the President said he would veto any cuts proposed by Congress to Social Security and/or Medicare. These are two of the big three items in our national budget, defense being the third item. I also reiterate that our country cannot continue increasing our national debt without dire consequences. Our debt is now 121 percent of our gross domestic product (GDP) for one year. I can remember when Treasury said we wouldn't let our national debt go over 100 percent of GDP. The slide toward indebtedness is very slippery; ask any young couple that went over their heads in credit card debt. It is projected that in ten years, if the 118th Congress does not take action, seventy percent of every tax dollar will be going toward interest on our national debt.

In the NARFE webinar John Hatton stated that, due to our now divided government, the promises made in the "State of the Union" message, and the nation's current debt problem, NARFE will be busy protecting our retirement and health benefits, item 1 on the list above.

Also, it is important to make sure that the OPM Information Technology Working Capital Fund, item 2 above, and originally funded by the 117<sup>th</sup> Congress, is not sidetracked.

I remind our readers that the previous administration tried to derail our new Bangor Seawolf class submarine pier extension project and use the appropriated funds for further development of the Rio Grande River wall. This pier extension is now complete and is home to our USS Seawolf.

All this leads up to our March emphasis, NARFE-PAC Month. I urge you to

#### **COLA UPDATE**

The January CPI-W value is 293.565, which is .57 percent higher than the Jul/Aug/Sep 2022 average of 291.900666.

The October 2022 CPI-W value was 293.003; November and December 2022 values declined from the October high. The January value has leap-frogged the November and December lower values with January being .86 percent higher than December.

The January over December increase, mathematically, calculates to an annual inflation rate of 10.36 percent.

#### **MEMBERSHIP & MUSINGS**

I will see if we can find any legislative news for you. You need to hunt for any good news from Congress these days. I did find two bills in the House that may be of interest to you. First, H.R. 716 would provide for cost-of-living increases for certain federal benefits programs based on increases in the Consumer Price Index for the Elderly (CPI-E). Sponsored by John Garamendi, D-CA and introduced on February 1, 2023, it has 22 co-sponsors (none from Washington State). It's been referred to the Committee on Ways and Means, and to the committees on Veterans Affairs, Oversight and Accountability, and Armed Services. This change in law would allow us to switch from the CPI-W, which we currently use, to the CPI-E to more accurately show our true costs.

Second, H.R. 536/S.124, sponsored by Gerald E Connolly D-VA and introduced on January 26, 2023, has 47 House co-sponsors (including Kilmer and Jayapal) and 16 Senate co-sponsors (none from Washington State). It has been referred to the House Committee on Oversight and Accountability. This legislation would ensure that cost-of living adjustments (COLAs) for Federal Employees Retirement System (FERS) annuities match the measured change in consumer prices. Currently FERS retirees do not receive a full COLA if consumer prices increase by more than 2 percent annually. Contact your representative and ask them to co-sponsor these pieces of legislation.
