# Treasurer's Report

The February balance is \$15,247.73. Dues collected in January were \$48.80.

### Membership

Our chapter membership is 157. Four members were dropped for non-renewal from 1 October to 1 February 2023 and 19 members renewed. Three members, Vern Moore, Olympia, Jackalyn Cebula, Yelm and Juanita Cross were reported passed away. Our condolences to their families. Five members whose deaths occurred prior to 2021 were dropped from the rolls. These members were non-dues paying life or honorary members. With these types of membership, NARFE never learns of their passing if the families are not aware of their NARFE membership. Our chapter member numbers are gradually shrinking. When you have the opportunity promoting NARFE membership to an eligible friend or acquaintance is a desirable something to do. NARFE performs a vital role in advocating before Congress our interests as retirees or active federal workers. So, if you know someone who works or worked for the Feds, use your persuasive powers on them to join NARFE.

#### **TSP**

January was a positive month for stocks on the Wall Street. All the various TSP funds except one increased in value. With the rise in interest rates the G fund now has a 3.12% annual return. Falling inflation, moderating wages and record-low unemployment would seem to indicate a soft landing despite the Federal Reserve's actions. However, there are nay-sayers. Bank of America strategists warn that investors could face brutal declines if economic growth crumbles in the second half of the year. The risk is if inflation flares up again over the next few months. So, what should TSP stock investors do. The advice would be is pay attention to what the economy is doing. Enjoy the gains while they come and for retirees flee to the G fund if a recession kicks in. Treasury Department has suspended G Fund credits while the fight over raising the debt ceiling is settled. The fund will be made whole when agreement is reached and the debt ceiling is raised.

#### **COLA UPDATE**

The December CPI-W value is 291.051 as compared to November's 292.495 value. That equates to a slight decrease in the inflation rate.

#### **PAC**

March is NARFE-PAC Month. The goal for the 2023-2024 election cycle is to raise \$1.6 million, disburse \$1.2 million in political contributions and send NARFE members to 125 local fund raisers. Chapter 236

members contributed \$3,430.00 in the 2021-2022 election cycle. There were 30 contributors and 1 sustainer. Thank you to all our chapter contributors. Let's meet or beat those numbers for the next two-year cycle. If you want to contribute on an annuity withholding basis, you can find the form to compete on the NARFE website in the Advocacy/PAC area. # **Legislative Action**

It's a new year and a new congress. All the proposed legislation died with the old Congress including all of NARFE's supported bills. On January 9<sup>th</sup> HR 82 – Social Security Fairness Act of 2023 was reintroduced by Representative Garret Graves (R-LA) and was referred to the Ways and Means Committee. To date the act has 128 sponsors, three of whom are Washing State representatives Rick Larsen, Dan Newhouse, and Derek Kilmer. House Rules will force either committee action or a floor vote if the bill receives 290 or more co-sponsors and retains that number for 25 legislative days. This is where you come in. Contact your Representative and urge them to co-sponsor this bill, or if they already have thank them for doing so. The bill attained this status last year, but it still did not reach the floor for a vote of the House. The reality is with a GOP majority the legislation is even less likely to pass.

#### Alzheimer's

Last September the drug companies Biogen and Eisai revealed that a drug Lecanemab reduced both cognitive and functional decline in patients by 27% in a phase 3 clinical trial conducted in North America, Europe and Asia. The trial of 1795 adults aged 50 to 90 who had mild cognitive impairment due to early Alzheimer's or mild Alzheimer's disease related dementia was conducted from March 2019 through March 2021. The trial found that Lecanemab was linked with less cognitive decline and more clearance of amyloid plaques (protein fragments associated with Alzheimer's disease) after 18 months than the placebo. However, there were also adverse effects. As a result, longer trials are warranted to determine the efficacy and safety of Lecanemab in early Alzheimer's disease. There is however no treatment in research to stop its development or progression to severe stages. Forms to make contributions to Alzheimer's research are on page 31 of the January NARFE magazine.
