#### **PRESIDENT**

Our elected congressional representatives will be busy behind the scenes this spring, working out budget proposals to show some sort of control over spending. We expect some congressional action on this issue by summer. As stated in last month's newsletter, NARFE expects to be busy protecting our retirement and health benefits. President Biden said he would veto any proposed cuts to Social Security or Medicare which are the largest part of the budget. However, Medicare will not be able to pay out its promised benefits in just five years, Social Security in twelve years.

Meanwhile, the Federal Reserve, or Fed, has been busy fighting inflation. They raised the prime interest rate from 4.75 percent to five percent in March, the highest it has been in sixteen years. Their

next review will be in May, but they didn't raise their terminal rate target of 5.1 percent for year end. The Fed's goal is to chill the U.S. economy but not put it into a deep freeze. They had a scare when two midsized banks went bankrupt in March. These banks got into trouble due to these higher interest rates which pummeled the value of Treasuries and other bonds they owned coupled with poor risk management practices with no monitoring. The Fed introduced an emergency lending program to defuse the turmoil. The Federal Deposit Insurance Corporation (FDIC) and Treasury Department stepped in and guaranteed all uninsured deposits.

The goal is to get the inflation back down to two percent. This is going to be a long-term problem and it is going to be painful. The credit market is going to tighten and projected growth in the national economy as going to decrease to less than one percent this year. Banks are going to be more cautious in their lending which will make it harder for consumers to get auto or other loans. One good item is concerning home prices: The median home price is now \$363,000. This price drop in February is the first time the median monthly home price has fallen in over ten years. So be aware of the bumpy road ahead. The goal is to eliminate fragilities and get back to a solid economy.

The February 2023 CPI-W value is 295.057. February inflation rose .508 percent over the January value. Based on the February increase multiplied by twelve months, the annual inflation rate is 6.09 percent.

The February value of 295.057 is 1.08 percent greater than the Jul/Aug/Sep 2022 average of 291.90066.

Cray retired after 32 years of government service in leading teams and organizations involved in high technology programs and systems acquisition. He worked for the Department of Defense as the Director, High Performance Computing Modernization Program, where he provided leadership and management for six performance computing centers, more than 50 high performance computing software development efforts, and the defense research and engineering network (DREN). He was also Deputy CIO, US Army Corps of Engineers, where he provided leadership and governance over USACE IT policies and procedures. His background includes systems software engineering. design and analysis. communications/network engineering, legislative relations, financial management and corporate governance.

Besides stepping up to be our federation president, Cray now volunteers with the Northwest Maritime Center by working in the boat shop; working as a local community lifeguard; and serving as the secretary/treasurer of his community's homeowner's association. Other interests include maintaining small wooden boats, building a radio-controlled (RC) sailboat, and racing RC sail boats.
