President's Message

As we enter May 2023, we continue to encounter more fresh challenges to our organization which by all accounts will continue into the foreseeable future. Congress continues to assail "America's Heartbeat" from every possible angle. Currently there is a stand-off between the Administration and Congress as to raising the debt ceiling. In past years raising the debt ceiling was routine. Now it is a political fight over how to reduce government spending. The Debt Limit Playbook for many members of Congress includes Federal Employee benefits high on the list of targets to cut. These include compute employee retirement annuities based on the highest 5 years of service rather than 3 years; increasing employee share of contributions to FERS and reducing or even eliminating COLA's to FERS and CSRS annuities; eliminating the FERS annuity supplement; reducing the rate of return of the TSP G fund; creating a TSP type retirement system, voucherize the government share of the FEHB premium, and implement the Chained – CPI as the measure of the annual COLA's. The Chained – CPI is based on the mix of goods that consumers actually buy rather than on a fixed basket of goods. The BLS conducts price surveys using both systems. The Chained – CPI is considered a more accurate gauge of the cost of living. On the other hand, it is a less timely indicator and a less accurate measure of the current rate of inflation.

Based on what is happening in DC at this time, we as a chapter must continue to make our voices heard by Congress. It doesn't matter if you write a letter in longhand or with a pencil and pen, pick up the phone to call your local Member of Congress's office, or log on and use the wonderful GEMS service provided on the NARFE website. **WHATEVER** the method, **MAKE YOUR CONCERNS KNOWN!!!** The numbers recorded of those who have contacted Congress in recent years is not what would be expected of an organization with a charter dedicated to political activism. We are as strong as we can make ourselves. Once again, please call or write to your Member of Congress on those issues which affect you most as a federal retiree.

The March CPI-W value is 296.021. This represents to date a 1.4% increase in the 2024 COLA according to the NARFE website.

LEG CON 23

LEG Con is NARFE's premier grassroots training event on how members can promote NARFE's legislative agenda to your members of Congress will be held in June. The conference is a virtual event. The link to registration information is on the home page of NARFE's website. The cost is \$150. The Washington State Federation will reimburse you for the registration fee. Legislative Action

Senator Sherrod, D-OH, and Senator Susan Collins, R-ME reintroduced the Senate version of the Social Security Fairness Act, S. 597. This bill would fully repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). It has 38 cosponsors and was assigned to the Committee on Senate Finance. The House Companion bill, H.R. 82 has 232 cosponsors and languishes in the House Committee on Ways and Means. Legislation has been submitted in both houses, Saving the Civil Service Act, H.R. 1002 and Senate bill S.399, to prevent the return of schedule F, a statutory loophole created by the previous administration which would change several thousand civil service jobs to political appointment status, the old spoils system. Neither H.R. 2002 nor S. 399 are cosponsored by any Washington State congressional representatives. Please ask your senators and representatives to cosponsor these bills.

OPM Begins Process to Establish the USPS Health Benefits Program

OPM has begun accepting applications from health insurance companies to be part of the USPS health benefits program. The new program is effective 1 January 2025. Unlike the existing FEHB program the USPS employees and retirees will apply directly with OPM through an online portal to select insurance coverage. During the open season period in Fall 2024, eligible postal workers and retirees will have the opportunity to select their new coverage. The CBO estimates the new program will lead to lower average costs for both postal and other Federal employees.
