President's Message

As we enter July 2023, we continue to encounter more fresh challenges to our organization which by all accounts will continue into the foreseeable future. Congress continues to assail "America's Heartbeat" from every possible angle. Supposedly a government shutdown was eliminated by the agreement between the Administration and the Speaker of the House. However, members of the House are asserting the Debt Ceiling Agreement only established a spending ceiling not a floor and further cuts to spending are necessary. Congress will try to pass 12 appropriation bills before October to cover all government spending. House proposals to date call for an additional \$120 billion reduction in spending below the ceiling agreed upon. The House Appropriations sub-committees have already adopted bills that would cut spending for agriculture, the FDA and for energy and water development. More cuts are coming. Lower spending levels could make it harder for the House to reach agreement with the Senate. It is possible Federal agencies could have to shut down if the two chambers are unable to agree on spending levels by October. The end of the Fiscal Year is 30 September. Complicating all these spending issues is the insertion in various bills such as Defense Appropriations provisions on social issues such as abortion, transgender care for teens, diversity in training on DOD, etc. And of course, House members are recommending the usual list of cuts to Federal employee and retiree benefits. These include compute employee retirement annuities based on the highest 5 years of service rather than 3 years; increasing employee share of contributions to FERS and reducing or even eliminating COLA's to FERS and CSRS annuities; eliminating the FERS annuity supplement; reducing the rate of return of the TSP G fund that would make it worthless; changing FERS to a TSP benefit only; preventing TSP from including investments based on environmental issues which means TSP could no longer offer a mutual fund investment option: providing only a flat amount for the government share of the FEHB premium, and implement the Chained - CPI as the measure of the annual COLA's.

Based on what is happening in DC at this time, we as a chapter must continue to make our voices heard

by Congress. It doesn't matter if you write a letter in longhand or with a pencil and pen, pick up the phone to call your local Member of Congress's office, or log on and use the wonderful GEMS service provided on the NARFE website. **WHATEVER** the method, **MAKE YOUR CONCERNS KNOWN!!!** The numbers recorded of those who have contacted Congress in recent years is not what would be expected of an organization with a charter dedicated to political activism. We are as strong as we can make ourselves. Once again, please call or write to your Member of Congress on those issues which affect you most as a federal retiree.

IRS ANNOUNCES NEW DIRECT FILING SYSTEM

Last month the IRS released a study examining the feasibility of Direct File, an IRS run electronic filing system for taxpayers. If implemented, Direct File would be a free online tax preparation and filing tool available to all taxpayers. The IRS plan is to launch this program with a scaled pilot program in 2024. In other words, a randomized controlled trial with a sample of randomly selected taxpayers. If finally implemented, this is a dramatic change to filing taxes. We all have heard about the complaints regarding the big tax preparation companies taking advantage of low-income and unknowing customers with extra fees and services not needed or even supposed to be free. These companies certainly are not going to be happy to see a loss of business. It seems if the IRS is allowed by Congress to implement a free filing system this would be of great benefit to many people including us retired Federal employees.
