#### **PRESIDENT**

With summer almost gone, it is time to refocus our attention away from summer travel and leisure. As previously reported, June was LEGCon23, which was NARFE's virtual legislative training conference. Our secretary, Bea Bull, and I attended via Zoom. This provides a significant savings for our chapter since it eliminates travel and accommodations involved when sending a representative to Washington DC. Plus, our Washington State Federation (WSF) reimbursed our registration fees. We met as a virtual group from our varied legislative districts and discussed the NARFE Magazine "Bill Tracker" items with our western Washington congressional representatives' aides. We also met with Senator Cantwell's aides. We received positive feedback on all items except the Government Pension Offset and Windfall Elimination Provision (GPO/WEP). Congressman Adam Smith's aides said there are reasons this legislation has not passed, the first being that the cost is prohibitive in its present wording. Second, Social Security's formula for payment is meant to favor low-income retirees, not retirees who have both Social Security and federal retirement.

Our speaker for September's meeting is a reschedule from June. Sheila Taylor from Clutter Controllers will teach us how to declutter our homes. This works out very well with the West Side Improvement Club's (WSIC) rummage sale on 7 October. We (NARFE) will have two tables at this sale so <u>bring your items</u> that no longer fit your home decorating scheme for us to sell. <u>All proceeds will be donated to Alzheimer's research</u>. The sale is 7 October but <u>we will be taking donations starting at our September chapter meeting</u> at the WSIC. So, you have two reasons to come to the meeting or send your spouse. #### COLA UPDATE

The inflation trajectory has been consistent. The July CPI-W value is 299.394 and that is .34 percent higher than the previous month value. So, July stands at 2.567 percent higher than the Jul/Aug/Sep 2022 average value of 291.90066. We are headed for a 2.9 or 3 percent COLA at this pace.

#### SEPTEMBER LEGISLATIVE REPORT

In our June newsletter the legislative topic was national debt negotiations. As predicted, Congress made some minor adjustments to the budget and kicked the can down the road. Now there are still threats of a government shutdown, but the debt limit suspension runs through 2024 which is past the next congressional and presidential elections of November 2024. My point is that we succeeded in our prime NARFE objective. The budget deal stayed clear of federal employees' retirement and health benefits plus allowed for an increase in defense spending for 2024. This is all good for Bremerton Chapter 181 due to the defense industry employment in our area.

However, our NARFE National office is still pushing for increases in non-defense spending in the present Congress. The House of Representatives and President Biden have already agreed to cap non-defense spending at a 5 percent reduction in 2024 compared to 2023 spending. Agreed that there are caveats in the budget for specific items, but our 2024 wish list is not going to happen. The key to all of these negotiations is that voting matters, but that is a year off.

# **MEMBERSHIP & MUSINGS**

We will start off with a bit of legislation news about House Resolution 4260, Public Servants Protection and Fairness Act of 2023. This Bill was submitted by Representative Richard Neal (R-MA), introduced on 21 June 2023 and referred to the House Committee on Ways and Means. To date this legislation has 98 cosponsors. This bill would amend the "Windfall Elimination Provision" (WEP) by providing a monthly rebate of \$150.00 to current

beneficiaries, age 62 or older before 2025 and creating a new formula to calculate benefits for future WEP affected individuals turning 62 in or after 2025. As of this writing there has been no action by the House or Committee. Please contact your representative and urge them to support and cosponsor this legislation.

Well, here we are back from our vacation. This report covers one month and parts of two months, 21 June through 24 August.
