#### **PRESIDENT**

We had a good turnout for our September meeting featuring Sheila Taylor of Clutter Controllers. She presented several different efficient, space-saving variations for storage, especially kitchen cupboards, for those who are downsizing.

Between writing this article and publishing our October newsletter, we will hold our virtual Washington State Federation (WSF) Annual Meeting via ZOOM. The president of each of the remaining eleven WSF chapters will report their chapter activities, challenges, and needs. Hopefully this will help our state officers understand the breadth and depth of activities across the state. Also at this meeting, we will discuss the proposed in-person training event, annual meeting, and event social in the fall of 2024 at the Three Rivers Convention Center in Kennewick. In order to encourage attendance, the federation will probably pay all, or a portion of, the registration fee; but that still leaves your hotel and travel expenses.

As mentioned in our last newsletter, there is still time to bring your items for our two NARFE tables at the West Side Improvement Club's (WSIC) rummage sale on Saturday, 7 October, from 9:00AM to 3:00PM. All proceeds will be donated to Alzheimer's research. We will be setting up our table on Friday night, 6 October, from 4:00PM to 7:00PM. **Please call me at 360-473-6301 or 360-377-7917 for drop-off instructions.** 

We were hit with a price increase for rental of the WSIC hall that we did not expect. We use the main hall for our membership meetings on the second Monday of each month except July, August and December plus we use a conference room for our executive board meetings monthly except July. We paid \$250 last year for usage and budgeted \$300 for this year. However, this year we are being billed \$900 which is \$100 per month for hall rental. Conference room usage is free due to billing of their main hall for membership meetings. WSIC has seen a considerable drop in bingo profits recently which spurred this hall rental increase to keep their club viable. Bingo was their main source of income. If you have comments or concerns about this price increase, come to our executive board meeting at the WSIC at noon on 4 October. Treasurer Tauscher and I went to WSIC's September board meeting and stated our discomfort with the way they implemented their rate increase.

#### **COLA UPDATE**

Interesting CPI-W today, 13 September 2023. This is a picture of monthly inflation since April:

April = .577 percent May = .219 percent June = .340 percent July = .169 percent

Aug = .551 percenter

This August jump in inflation puts our COLA at 3.3 percent. If September inflation is at least as much as July inflation, July and September cancel each other out when averaging July, August and September. It looks like a 3.3 percent COLA is shaping up, if not more.

#### OCTOBER LEGISLATIVE REPORT

At press time the House of Representatives is holding up 11 appropriations bills. This is due to an ideological battle over Speaker McCarthy's agreement with President Biden to lift the debt ceiling. The agreement also included the Fiscal Responsibility Act which held fiscal year (FY) 2024 top line spending numbers to that of FY 2023. The House of Representatives hardline Freedom Caucus actually wants to lower FY 2024 spending. Their point is that, annually, the US Government takes in approximately \$5 trillion but spends approximately \$7 trillion. That is why the federal deficit is approximately \$34 trillion. What most Freedom Caucus lawmakers are attempting to achieve is straight forward: Much needed border security and real budget cuts. What most main-street Americans want is a well-functioning government. A well-functioning economy requires a functioning government which includes tax collection with fair and equitable management.

What has happened in the past to keep the government open is a continuing resolution. That would extend FY 2023 spending levels for a designated period of time, probably into November. The next step Congress can take is an omnibus spending package which rolls all fiscal year spending into one very big package for a vote up or down. This is not desired because the package is so big that the lawmakers don't know what they are voting for or against and it's difficult to

amend. However, if no appropriations bills get funded and there is no continuing resolution then there will be a shutdown with no clear path for reopening the government.

Congress, President Biden and the Federal Reserve

have a lot of issues on their plate this coming year including: Ukraine military aid; border security provisions; artificial intelligence funding; the Biden impeachment; the Trump indictment; disaster relief fund replenishment; the auto strike in Michigan, Ohio, and Indiana; the Hollywood writer's strike; Schedule F; and inflation. I don't think 2024 is going to be the year we see government spending cuts.

#### **MEMBERSHIP & MUSINGS**

We will start this with a legislative note. Over 30 years ago two laws were passed: The Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). Almost as soon as these laws were passed NARFE had legislation before Congress to repeal them and this 118th Congress is no different with HR 82 Social Security Fairness Act of 2023. As of this writing, this bill has 292 cosponsors: 199 Democrats and 93 Republicans. The experts give this legislation very little chance of passing this Congress. As time marches on the WEP and GPO effect fewer and fewer federal retirees. In the meantime, we need to keep this repeal legislation (HR 82) in the hearts and minds of our legislators.

To start our membership report, Bremerton Chapter 181 now has 393 members onboard. The following four members were dropped for nonpayment of dues: Rocco Bagala, John Schaleger, Kerry Stevens and George Wood. If you are familiar with any of these members, please urge them to renew their membership.

We have one new member, Theo Cragg, who joined us this month. Welcome to the Bremerton chapter and, if we may be of assistance in any way, please let us know.

**Editors Note:** Additional legislation has been introduced in the 118<sup>th</sup> Congress to repeal or reform the WEP/GPO. HR 4260 The Public Servants Protection and Fairness Act would reform WEP/GPO by creating a new formula for calculating Social Security benefits. HR 4583 Social Security 2100 Act would repeal the WEP/GPO. Both pieces of legislation are listed in the *NARFE Magazine* "Bill Tracker" section.
