#### **COLA UPDATE**

The August CPI-W index value of 301.551 represents a 3.4% increase over the last 12 months. The monthly increase is 0.6%. It is estimated the 2024 COLA will be 3.2%. The Federal Reserve announced 20 September interest rates will remain the same for now. The 2024 COLA will be announced in mid-October when the September CPI-W index value is released.

#### **VACCINES**

## FEDERAL LONG TERM CARE INSURANCE PROGRAM (FLTCIP)

I assume at least some of our chapter members purchased a FLTCIP policy and have received a recent letter from OPM advising you of a significant increase in rates. You will have to decide whether to pay the new rates or select from among options for a reduced benefit amount, a cut in inflation protection or reduced benefit period to keep the current rates. A decision is required by 9 November. Your newsletter letter editor and wife purchased policies about 15 years ago through an insurance agent. The cost was reasonable and the same for several years but in recent years there have been cost increases and the increase for next year is the biggest yet. We had to think about whether to accept the increase or select from three options for reduced benefits and thereby a lower price. It comes down to can one still afford the insurance at the increased cost. If you can, it is better to keep the current coverage and pay the increase. The US Department of Health and Human Services estimates that 70% of adults who survive to age 65 develop the need for long term care services and support before they die and 40% will need some paid services over their lifetime. In other words, the cost of the care you receive will exceed the cost of the plan premiums you paid. As of December 2022, the plan had 260,000 enrollees and paid out a total of \$2.4 billion in claims with an average claim of \$90,000.

#### FEDERAL HEALTH BENEFITS OPEN SEASON

The open season to enroll, change plans or plan options is November 13 to December 11. Health plan premiums will rise on average 7.7% in 2024. Dental plans will increase by an average of 1.4% and Vision Plans by 1.1%. Additional benefits coming in 2024 include covering of FDA approved anti-obesity medication and Improved access to mental health and substance abuse disorder services including telehealth at low cost or no cost sharing. You can find a good overview of the plan changes for 2024 on pg.36 of the NARFE magazine. Just a reminder to our Postal Service Members, the separate Postal Service Health Benefits coverage starts in 2025.
