#### PRESIDENT

November is the Federal Employee Health Benefits (FEHB) program month. The first of three health fairs will be Wednesday, 1 November from 7:00AM to 5:00PM in downtown Bremerton at the Kitsap Conference Center on Washington Ave. It is a walk-in setup, arranged so shipyard workers can leave their job site throughout the day and visit health care representatives to get brochures and questions answered by experts. Retirees and survivor annuitants are also welcome but parking is limited. Our Chapter 0181 will staff a table at this event so, if you attend, stop by and say "hello".

The second event is an open-house on Saturday, 4 November from 9:00AM to 1:00PM at the Silverdale Beach Hotel on Bucklin Hill Road. This event requires an RSVP so, if you plan to attend, call 425-381-8523.

The third event is our annual health fair on Monday,

13 November from 10:00AM to 1:00PM at the Westside Improvement Club off National Avenue. This one is mainly for retirees and survivor annuitants, though current federal employees are always welcome. There is plenty of parking and the health fair is followed by our regular monthly chapter meeting during which each health care representative will give a short talk and answer further questions from 1:00PM to 1:30PM.

One item of concern is prescription drug coverage for those people not eligible or on Medicare Part D. The Inflation Reduction Act of 2022 capped certain drug prices, e.g., insulin at \$35.00 per month, for those on Medicare. Those not eligible or not on Medicare and taking these drugs should question your FEHB provider to determine if they included this benefit in their 2024 insurance coverage.

If you are planning to change your health benefit plan, open season runs from 13 November through 11 December, 2023.

#### **COLA UPDATE**

The numbers are in. The COLA will be 3.2 percent for CSRS retirees and Social Security. The FERS "diet" COLA will be 2.2 percent.

#### NOVEMBER LEGISLATIVE UPDATE Bill Powers

Representative Mike Johnson (R-LA) has been elected Speaker of the House of Representatives. Johnson is a relatively unknown 51-year-old conservative Republican serving his fourth term as representative of Louisiana's 4<sup>th</sup> Congressional District. He represents one of the poorest congressional districts in America according to US Census data. He is an ally of former president Donald Trump and opposed certification of the 2020 presidential election. He voted against Ukraine support but is a strong supporter of Israel.

Johnson realizes that the 17 November deadline for passage of all 11 appropriations bills to avert a partial government shutdown is a tall order. He floated a stopgap measure (continuing resolution) to avert a shutdown, the very move that sparked McCarthy's ouster. He floated 15 January 2024 as a new deadline for passage of all appropriations bills. So far there has been no kickback.

Johnson is one of the authors of the "Republican Study Committee 2024 Budget". This budget addresses our federal spending and balances our budget in seven years plus cuts spending by \$16 trillion over ten years. Basically, this proposal revises paid leave policies, eliminates automatic step increases, revises federal employees' pension plans including reducing COLAs for FERS & CSRS, reforms the interest rate on the Thrift Savings Plan G fund, increases the employee portion of costs for healthcare, and implements the chained consumer price index.

I do not think these items will be implemented due to our divided government but there are a few items in this proposed budget not listed above that will probably be implemented. America's debt is unsustainable at its present rate so Congress has to eventually quit kicking the can down the road. That is the message of the Republican Freedom Caucus that caused all the uproar for the last month.

#### **MEMBERSHIP & MUSINGS**

I would like to start with a positive legislative note. The House of Representatives elected a speaker on 25 October. This will allow the House to start working on the 2024 budget. We should note that all spending bills must start in the House, that is the rule. Remember that the 2024 budget runs from 1 October 2023, to 30 September 2024. The federal government is presently operating on a 47-day continuing resolution that extends the 2023 budget spending levels to 17 November when this resolution expires. We should assume that there is still work to be done on the 2024 budget, but how much work and how long it will take to finish is anyone's guess.

Now we will get on with our membership report. Bremerton Chapter 0181 now has 396 members on its register. One member, Margaret Lentz, was reported as deceased this month. Our condolences to her family.

We have three new members: Tim Boom, Jeffrey Green and Janice McCarry. We welcome you aboard and hope to see you at a meeting. Virginia Julian reinstated her membership; thank you very much. Thirteen members renewed their membership for another year or multiple years. Thank you for what you do for NARFE. Because of you we can help federal employees and retirees everywhere.

**Editor's Note:** On 19 October, Congressman Derek Kilmer reintroduced the Federal Retirement Fairness Act, H.R. 5995. This is the legislation to allow civilian service in a temporary position after December 31, 1988 to be creditable service under the Federal Employees Retirement System.
