The Association, since July 1970, has been classified by the IRS as a 501c (5) tax exempt labor organization [not a union]; however, dues, gifts, or contributions to the Association are not tax deductible as charitable contributions.

From President Bob:

As we come up on Thanksgiving, I want to note how thankful I am to have the many benefits I earned as a Federal employee and to those who work to help me keep them.

As of 1 Nov, we now have 298 cosponsors for the H.R. 82 Social Security Fairness Act of 2023. If passed, this legislation would eliminate the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO). Representatives Kristina Marie Gluesenkamp Pérez and Adam Smith are the only two from our state not to cosponsored this legislation. If you live in Congressional District 3 or 9, please urge them to cosponsor H.R. 82. Also S.597, the Senate bill, has 46 cosponsors but Senator Marie Cantwell has not joined the cosponsors. All members should urge her to sign on too.

FEHB Season is from 13 Nov to 11 Dec. Be sure to review the plans for changes. This both to see if there is a reason to change plans and to see if you have some new benefits. There are currently several new webinars on choosing the best plan for you. Also you may want to see how the introduction of Medicare Advantage plans affects you.
