We held our election for Chapter 0181 officers during our November chapter meeting. All officers were reelected by acclamation and Mary Traxler will install them for another two years at the December meeting.

We are still interested in appointing volunteers for membership chair and legislative-national chair. The membership chair keeps track of our new members, past-due and dropped members, and deceased members. This position has two people assisting with retention efforts. The legislative chair

So far, four candidates have either throw their hat into the ring or have appointed a study committee to consider running for his position. As for our NARFE “Bill Tracker,” Congress has kicked the can down the road to be resurrected in January 2024. However, the Social Security Fairness Act, H.R. 82, is getting constructive dialogue in the House Ways and Means Committee. This is where Government Pension Offset/Windfall Elimination Provision died in the last Congress.

On a positive note, due to NARFE's partnership with the Alzheimer's Association and NARFE chapters across the United States, including our Chapter 0181 contributions, NARFE will close out 2023 very close to the 2024 goal of \$16 million. Thank you for your donations!

COLA UPDATE

The cost of living remained the same through mid-November. As a reminder, the COLA for 2024 will be 3.2 percent for CSRS retirees and Social Security. The FERS “diet” COLA will be 2.2 percent.

Washington State Federation Legislative-National Coordinator Doug Rushton will explain in the January newsletter why FERS retirees receive a lower COLA (spoiler alert: It has to do with a trade-off for receiving employer matching funds for TSP contributions) and why NARFE now supports legislation for equal COLAs for FERS retirees.

Derek Kilmer has been our Sixth Congressional District representative (which includes Bremerton and environs) for over ten years. He has been a tremendous advocate for issues and concerns important to NARFE and its members. He has always been ready to listen and willing to assist his constituents.

Kilmer to NOT seek Re-election

Derek Kilmer, our Sixth Congressional District Representative, announced in a newsletter dated 9 November 2023 that “**I will not seek re-election next year**”. He noted it was an honor representing his hometown of Port Angeles – and the entire Olympic Peninsula.

He mentions a few items in his newsletter:

- Led the Select Committee on the Modernization of Congress (aka “The Fix Congress Committee”) where he enjoyed working with the cohort of nonprofits, think tanks and academics who dedicated time and energy to making government work better. He notes there is a lot more work to do.
- “There are other projects I’ve told my kids about, trying to show them we can do things better when we do things together” - working in coalitions to fix the traffic problems, manage our forests in a smarter way, get a new veterans clinic built, ensure the federal government fulfills its trust responsibilities to Tribes and protect Puget Sound.
- With more chapters for his life - “My plan is to ensure those chapters enable me to continue to make a positive difference. And I’d sure like to make a bit more time for those I love.”

On a related note, Washington State Commissioner of Public Lands, Hilary Franz, announced on 10 November she is dropping out of the 2024 governor’s race to run for the Sixth Congressional District slot. She has been endorsed by Congressman Kilmer.

Federal Retirement Fairness Act

Reintroduced on 19 October 2023 by Congressman Kilmer, H.R. 5995 Federal Retirement Fairness Act would allow *temporary* federal workers to apply their time to their federal retirement. On 25 October 2023, it was referred to the House Committee on Oversight and Accountability.

As of 25 November, there were 32 cosponsors including Third Congressional District Representative Marie Gluesenkamp Perez. If you live in one of the other congressional districts, please urge your representative to cosponsor this legislation.

I am looking for more positive legislative news, which is hard to find these days. Looking at the “Bill Tracker” in the December *NARFE Magazine*, H.R. 1301/S. 640 Federal Employees Civil Relief Act only has three cosponsors in the House and 15 in the Senate.

This legislation “Protects federal workers and contractors from a variety of civil financial penalties during a lapse in appropriations or a breach of the debt ceiling.” H.R. 1301, sponsored by Congressman Kilmer, could use our help getting additional cosponsors. If you live outside the Washington State Sixth Congressional District, please urge your representative to cosponsor H.R. 1301. Neither of our Senators has cosponsored S. 640; please urge them to do so.

These pieces of legislation are important because Congress still does not have a 2024 budget in place. We should not become complacent about this issue. Yes, Government is running or limping along, but certainly not as it should be.

Now we will get on with our membership report. This report covers the dates from 25 October to 22 November. The Bremerton chapter now has 393 active members on its roster. We have two members dropped for nonrenewal: Bob Dill and Chester Hembree. If you know either of these members, please ask them to renew their membership.
