<u>Alzheimer's.</u> NARFE and its members have long been a major support of actions regarding Alzheimer's research. Over \$14,000,000 in donations has been raised. The Chapter 236 Alzheimer's Chair would keep members undated on the campaign's activities, solicit voluntary donations , and coordinate fundraising activities such as the annua Alzheimer's walk.

<u>Membership Chair.</u> Membership is a task with several functions: recruiting new members, retaining existing members, and keeping track of membership records. Milt Oster has been handling membership on an ad hoc basis but would definitely appreciate a hand.

<u>NARFE-PAC.</u> A major portion of the NARFE mission is Advocacy, reaching members of Congress who write or vote on issues of interest to federal employees and retirees. One of the best ways to reach them in through coordinated funding. All NARFE-PAC funds come voluntarily from individual NARFE members, with the average donation amount of \$52.50. Legislative Action - WSF President Steve Roy

There are two pieces of the Windfall Elimination Provision (WEP) that we need our congressional representatives to co-sponsor:

- H.R. 5834 – "Support the Equal Treatment of Public Servants Act of 2121". Introduced in the House by Rep. Kevin Brady, R-Tx, this is the latest bill that would provide financial relief to more than 1.9 million Social Security beneficiaries affected by the WEP.

- H.R. 4788 – Support the Wellbeing for Every Public Servant Act. This legislation would fully repeal the WEP for retirees with a combined non-Social Security covered annuity and Social Security benefits of \$5,500 and lower. For those with benefits above \$5,500, the WEP repeal gradually phases out, and for combined incomes at \$6,333 and above the WEP is fully applied.

To date no congressional representatives from Washington State have co-sponsored these two bills. I urge you to contact them by either using the NARFE Legislative Action Center at NARFE.org to write a letter; or by calling the NARFE Legislative Hot Line at 800-456-8410 option 5. Follow the prompts to reach your congressional representative.

Alzheimer's

In 2021, NARFE members donated \$278,127 to the Alzheimer's Fund. Two new research grants were awarded to Pablo Contreras, Ph.D. – "The Role of Bassoon in Tau Pathophysiology" and Yi-Chen Hsieh, "Ph.D. – "The Ubiquitin-Proteasome System in the Degradation of Tau in Alzheimer's Disease Neurons". 
You may have read that the new Alzheimer's drug ADUHELM developed by Biogen, was conditionally approved by the FDA for use in cases of mild Alzheimer's-related cognitive decline. This approval was not recommended by the FDA advisory panel and has been criticized by many doctors in the Alzheimer's treatment field. The drug is administered once a month by intravenous transfusion. Biogen initially set a price of \$56,000 for a one-year treatment, but because so few patients were receiving this treatment, Biogen reduced the price to \$28,000 in December. In the meantime, the Part B Medicare premium increase for 2022 was in part based on the \$56,000 price. Medicare issued a preliminary decision on 17 January that they would cover the cost of this treatment only for patients enrolled in randomized controlled trials which would greatly limit the number of people who would receive the drug. The preliminary decision is open for public comment. A final decision is expected by 11 April. The Secretary of HHS has directed the Center for Medicare Services to review the premium decision for Part B considering the reduced price for ADUHELM. Stay tuned for further developments.

NARFE-PAC. NARFE has partnered with the OPM to allow members to contribute monthly from their annuities directly to NARFE-PAC. This enables NARFE to avoid paying transaction fees for donations made by credit card. Further information is on page 10 of the December NARFE Magazine. This provides NARFE-PAC with a steady flow of funds that they can rely upon.
