PRESIDENT

Our March guest speaker will be Stephanie Hahn, Congressman Kilmer's Bremerton office Kitsap Outreach Representative. Since March is NARFE-PAC month, our other speaker will be Washington State Federation Legislative (National) Coordinator Doug Ruston. We will also give a demonstration for accessing the Washington State Legislative website.

Six of the "Let's Go Washington" initiatives have shown a lot of interest. Three of these will be taken up by the legislature and may be adopted prior to the November election. The other three will be voted on in November.

We have scheduled discussions with each of the 6th Congressional District candidates running for Congressman Kilmer's position. The first of the discussions will be with Hilary Franz; we will meet with her during our March executive board meeting. These discussions will continue, one each month, until we have met with all the candidates. The purpose of these meetings is to get to know these candidates, explain NARFE advocacy to them, and our position on a few issues.

All the Bills presented in the 118th Congress that are not made into law will have to be re-introduced in the 119th Congress if NARFE wants to continue advocating for these issues. One of these candidates, when elected, would become a junior member of the 119th Congress, and subject to co-sponsorship requests.

In last month's newsletter I discussed a problem with the new Defense Biometric ID System (DBIDS) badge to enter Naval Base Kitsap. I said that I would request assistance from our NARFE National office. The issue was brought to the attention of our Region IX VP Steve Roy to address at National. He reviewed it and determined that we should bring the issue up with our congressman's representative at our March membership meeting. I'll report on results.

Besides being NARFE-PAC month, it is also Washington's Presidential Primary month. Submit your vote in one of the white drop boxes by 12 March or by U.S. Mail a week early. Note that some candidates have dropped out of the race since the ballots were printed. There is also an option on the ballot to vote for uncommitted delegates. This means that there will be a certain number of Washington State delegates, depending upon the votes received for this category, at the national convention who are free to vote for any candidate of their choice on the first ballot.

LEGISLATIVE REPORT

As of the newsletter deadline, the Senate has tailored a contingency resolution for a short-term patch to extend government funding to two different dates, similar to the January stopgap deal. Speaker of the House Johnson will probably need a two-thirds vote threshold to pass this contingency resolution and get it to the President's desk.

Unfortunately, Congress doesn't seem able to come up with budgets for each of the different departments of government. It has been over 25 years since Congress passed a budget and actually lowered the government debt; that was during the Clinton Administration.

We will provide an update on budget negotiations next month. However, until Congress can agree on Ukraine support, Mexican border crossing negotiations, and Israeli/Palestine proposals, I think they will continue kicking the can down the road. As for the Federal Reserve, it sounds like they are going to keep borrowing rates "as is" until their July meeting. By then they should have enough positive data to lower rates.

On the brighter side, three stock market indexes hit an all-time high: the S&P 500, NASDAQ 100 and Dow Jones Industrial Average. All three closed at record levels. For those of you who own NVIDIA, it added \$277 billion in value, the most in stock market history. The company had triple digit revenue growth and its market cap is almost \$2 trillion dollars now. It deals with artificial intelligence and is breathing fresh life into the stock market.

Also on the brighter side, Odysseus successfully made a soft landing near the south pole of the Moon. This is the first privately built spacecraft to land on the lunar surface. It has been 50 years since an American spacecraft has made a soft landing on the Moon. By SpaceX getting involved in space exploration, they have brought costs way down.
