#### **PRESIDENT**

Congress has finally passed all 12 individual spending bills to fund our government through 2024. All these appropriation bills were initially due on 30 September 2023. The funding process has taken so long that it is now past time to start negotiations for the 2025 budget. The Executive Branch (President's) issued its 2025 budget wish list request in mid-March; there is zero chance of that being implemented unless there is a tsunami change in congressional representation due to November's elections. The 2025 budget is supposed to be implemented by 30 September 2024, which is before the November elections and before convening of the new 119<sup>th</sup> Congress in January 2025.

I bring all this up because our NARFE National organization has formed an advisory committee

for proposed changes to NARFE's advocacy positions for adoption by the National Executive Board. This is in preparation for addressing the 119<sup>th</sup> Congress. See the April 2024 issue of *NARFE Magazine*, page 12. NARFE mailed out a multiple-choice questionnaire during our recent "Winter Campaign" that I hope most of you read and some of you replied to concerning this advocacy issue. I sent in two separate replies, choosing the importance of various topics. If you didn't reply, you can still submit an advocacy position using the instructions in the above magazine article. They must be submitted by 1 June.

I maintain that our focus should be on items that are bipartisan and doable but still part of NARFE's Mission Statement on the President's page of our *NARFE Magazine*. The items we should be focusing on are items like protecting our cost-of-living adjustments for both working and retired federal employees, upholding the civil service merit-based employment system,

A former Washington State Representative, Tip O'Neill, once held the Speaker of the House position during Ronald Reagan's presidency. His mantra was, "All Politics Is Local". That is no longer true. What's happening in Washington, D.C. is driving the narrative.

### LEGISLATIVE REPORT

We have published several articles in our newsletter over the last two years concerning our national debt. The debt is now at \$34 trillion and debt-to-gross domestic product (GDP) is at 120 percent. The fastest growing part of our fiscal budget is interest payments on our national debt.

The debt deniers, whose mantra is "tax and spend" said we wouldn't pass 100 percent debt to GDP ratio. We are now well past the denial zone and into the danger zone. Our annual deficit spending in previous years was approximately \$1 trillion each year; now it's approximately \$2 trillion.

On the other side of the fence are the "no new taxes" oath legislators. Yet, the first items to be passed in the George W. Bush and Trump administrations were tax cuts.

Congress now has three separate commission proposals in hand to achieve a sound future for our country. They are the "Fiscal Commission Act of 2023", "Fiscal Stability Act of 2023", and the "Sustainable Budget Act of 2023". They all set up a commission with an equal number of Republicans and Democrats. One of them has private sector experts as part of the commission, but they are not voting members. Each of the commissions' plans needs a simple majority approval of members to advance to Congress. Congress must then vote up or down on the bill without any amendments.

Sounds simple but the devil is in the details. All three want to bring the debt-to-GDP ratio back down below 100 percent in ten years. This is entirely possible with equal cooperation on both sides of the aisle. However, various internet sources that figure the probability of legislation passing, has passage of any one of these bills at only 2 percent.

I would like to turn the clock back to 2010. The "Simpson-Bowles Act" to reduce the debt never got out of commission to be voted upon. The reason

being they had all these high ideas to reduce discretionary spending, reduce federal retirement benefits, reduce federal health care spending, raise Social Security age to 69, lower the federal income tax rate and, worst of all, they wanted to invoke the chained CPI.

My point is <u>both sides must give</u>, just not the working class. If the Simpson-Bowles Act had been enacted, it would have been like a giant Monopoly game. Whoever owns Park Place and Boardwalk with hotels wins. Game Over!
