Legislative Chair Report

I want to give special thanks to Steven Roy for his help, and specifically inviting our local legislative representatives to our recent NARFE meeting on April 20. We were fortunate to have two staff members from our U.S. Delegation join us in person: Hayden Jenkins (Sen. Murray) and Jessica Corbman (Rep. Larson). They reminded us that although staffers do simply count emails and letters (for/against proposed legislation), when they get personal stories from constituents it really does cut through the noise. We reminded them of current NARFE priority legislation (like the WEP/GPO repeal) and how these issues directly affect us. We made sure our August 14 picnic is on their calendars. I look forward to working with them in the future!

Here are two ways to keep in the loop on legislation. First, we can visit the NARFE website at http://narfe.org and visit the **Advocacy** tab, where you can get details (and NARFE analysis) on currently considered legislation, and easily advocate using web forms. Secondly, the front section of each *NARFE magazine* usually has informative articles, and the monthly *NARFE Bill Tracker*. We can access the *NARFE Magazine* online (with clickable links!) at http://narfe.org, click **FOR MEMBERS > NARFE Magazine Issues.** The May 2024 issue of NARFE Magazine has a nice article on page 10 about the importance of emails and letters to your representatives and Senators.

A recent development, S. 3974 Boosting Benefits and COLAs for Seniors Act, is a new companion bill for H.R. 716 (Fair COLA Act), you can read about and advocate for it using the NARFE Legislative Action Center https://www.narfe.org/advocacy/legislative-action-center/

I encourage all of you to participate in this 2024 election season, from your local races all the way to the Presidential race. Postal Retirees – Reminder

PSHB Special Enrollment Period (SEP)

As part of the new **Postal Service Health Benefits** (**PSHB**) **Program**, you may be eligible to participate in the PSHB Special Enrollment Period (SEP) for Medicare Part B. The PSHB SEP applies to certain Postal Service annuitants and family members who were entitled to Medicare Part A, but not enrolled in Medicare Part B as of Jan 1, 2024.

During the PSHB SEP, eligible annuitants and family members may enroll in Medicare Part B without paying a late enrollment penalty. <u>The one-time PSHB SEP is</u> <u>from April 1, 2024, to Sept. 30, 2024.</u> Individuals eligible for the PSHB SEP will receive notification by U.S. Mail[™] in March 2024.

All required information must be returned in the envelope provided and postmarked by Sept. 30, 2024. How to enroll during the SEP? Complete the provided CMS-40B form, Application for Enrollment in Medicare -Part B (Medical Insurance) and mail it with the copy of the notification letter in the return envelope you receive in March 2024. The return envelope must be postmarked by Sept. 30, 2024.
