Service Officer Corner

I am gearing up for our Federal Employees Health Benefits (FEHB) & Postal Service Health Benefits (PSHB) Open Season. It will be a big one with lots of changes especially for USPS employees, retirees & survivors and those other federal employees & annuitants that have a health benefit plan with one of the postal union carriers (APWU, Mail Handlers, NALC). We went through some big changes last open season with our prescription drug benefit in our FEHB and Medicare Part D. Hopefully through the year we have been paying attention to what changes have happened with our health benefits. The next opportunity to change insurance plans will be coming up during Open Season, November 11, 2024 – December 9, 2024.



Service Officer Corner (cont)

For all those folks that are/were with the USPS and are close to 65 years young or older, remember that the Special Enrollment Period (SEP) closes September 30, 2024. This is a SEP for enrolling in Medicare Part B without paying a late enrollment penalty. Another reminder is that all USPS employees and annuitants participating in FEHB will be required to select a PSHB plan during the 2024 open season.

The Everett chapter is planning to host at least 5 Open Season FEHB/PSHB Health Fairs within our chapter coverage area. Legislative Chair Report

I want to thank those that were able to attend our annual picnic on August 14. We had a turnout of 18, which included four guests representing Sens. Cantwell and Murray, Reps. Larsen, DelBene, and Schrier. We were able to share our "asks" with them and hear from them about what they see in the months ahead.

With much-appreciated support from our Chapter and the Federation, I was able to attend the biannual FEDcon24 conference in St. Louis, MO. It was three days of "drinking from the firehose" for this new NARFE officer. I learned much about NARFE, its mission, and its current priorities. One of the best parts of the conference was meeting the excellent NARFE staff, both officially and outside of "office hours". I was by myself at the bar in the restaurant and Matthew Sanderson and Ivana Sara popped onto the seats next to me. Matthew is the content manager for NARFE magazine (and the main "tech" for FedHub) and Ivana writes content about legislative initiatives for the magazine and develops our advocacy tools, like the webpage forms I demonstrated at our March Chapter meeting. It was enjoyable to learn about their backgrounds, express my appreciation for their fine work, and share with them what NARFE means to me. I was able to meet most of the other staff that were there, including the senior staff and some of the wonderful people who handle our membership. I was so impressed with them and am proud that they work for us at NARFE headquarters.

Probably the biggest action right now for us is that in the coming months two Congressmen are working to execute a discharge petition to force WEP/GPO reform (the Social Security Fairness Act, H.R. 82) to the House floor. If you have a chance, please contact your Member of Congress (Larsen, DelBene, or Schrier) and urge them to support the discharge petition for H.R. 82.

Washington ballots will be out in a few short weeks. Ballots for the Nov. 5 General Election will be mailed to eligible voters by Oct. 18. The deadline for online and mail registrations to be received is Oct. 28. You can register to vote or update your registration in person before 8 p.m. on Election Day, Nov. 5.

Also, the June-July issue of the NARFE Magazine has the candidate statements, the August and Sept. issues have the Bylaws and Standing Rules, and the Sept. issue has your individual paper ballot.
